### **Manager's Corner**

No manager note this month.



I hope everyone had a very Happy Thanksgiving. I truly hope that everyone enjoys the holidays and has a chance to enjoy time with family and friends. Being here is usually a struggle for a lot of us to visit with family. But the use of video chat and maybe just a phone call helps bring them closer. Thanksgiving to me, without family, is just not the same.

For those of you who have not kept up I will skim over the goings on over the past month. First on my list is the General Meeting regarding the vote on the HOA By-Laws on Nov. 16<sup>th</sup>. This was the first general meeting we have had in this Park since January of 2020. The Park is filling up and it was good to see familiar faces and new faces. It was also good to see a strong interest in our shared issues. This meeting was to address the proposed By-Laws that have really never been completely updated since 1988. We were able to make our quorum thanks to the proxies. The final vote was 73 yeas and 3 nays. So we have new By-Laws. It changes very little for the individual member; it does affect operations of the HOA.

At the same meeting the Nominating committee, chaired by Carol Roberts, presented the ballot for January 2022: Lori Dashiell, Kim Desrochers, Joe Feltner, Doug Irish, Bob McDermott, and Robin Sexton. There are short bios for each candidate in this issue of the Seagull for your information or

amusement. The Board Election is January 11, 2022 at 7:00 PM at the HOA Annual Meeting in the Clubhouse. Proxies are not allowed for elections, so your attendance is very important.

Negotiations are proceeding. The Negotiating committee, chaired by Kim Desrochers, is really working very hard on this very difficult task. She is doing an outstanding job. Everyone would be pleased by the amount of work she is putting into this very important effort. The one thing that has become very evident is that this committee needs to be formed early on in the year and it needs to continue throughout. Trying to learn what information to collect and collecting and organizing that information is not something that can effectively be done in just a few weeks. The committee is adding to their knowledge base and hopefully that will be passed on in the future to new committee members, thereby decreasing the learning curve. The first meeting went about as expected. We hope the second will go better. However, it became obvious to the Board and the Committee that legal counsel was needed. We have since obtained the services of a highly recommended attorney. This is in preparation for the very real possibility that we'll need to proceed to mediation. The Board believes that it would be foolish to not have professional help as we know ELS will.

Tie Downs should be over soon. Haven't heard many complaints. The ones we have heard have been in regards to communication and organization. Forms not getting to the contractors or contractors not knowing about certain homes. We have been working to make sure all this gets sorted out but we have had very little contact with the contractor, just the local on-site crews. Since we are an older park, many homes could only have portions done, and some not at all, D

due to clearance, obstacles, and other factors. But I guess, what can you expect for a free, government-sponsored project?

So, to all a Happy Thanksgiving. Despite all the worries and troubles many of us have had over the year, I do truly hope that everyone can find some joy or memory that they can be thankful for. It may be nothing more than today is a gorgeous day to be alive and being able to view the dawn. Personally I love watching the sunrise and I am very thankful that I have a beautiful, loving wife that I can very slowly and methodically drive nuts.



I am pleased to report that the tie down program should be completed in the next few days in our park. This program provides new tiedowns to homeowners who signed up to participate; new tie-downs at no charge. If any park owner who signed up for the program has been missed, please contact me immediately so that you are on their schedule. At completion, Storm Ready Services will be providing certificates for each homeowner. The paperwork will be delivered to the HOA President, Robin Sexton, and we will work with Robin to get them distributed to residents. It is recommended that homeowners contact their insurance companies, in hopes that this additional structural support will warrant a rate decrease. I want to recognize Ron Grove and FMO staff members for all their hard work in bringing this project to fruition.




### **Turning Pages: Sci-Fi Forever**

I've written before about my love for fiction in a series, works that invite the reader to travel, to explore, to linger in another world or alternate universe. Sometimes that

world is historical, and real, but these days the worlds of high fantasy and science fiction seem more appealing than ever. Perhaps it's the age; perhaps it's the socio-political climate; perhaps it's global warming or the increasingly powerful influence of technology—or perhaps it's just the cycle of literary tastes, but more writers are emulating the invented worlds of Middle Earth, Narnia, Earthsea, Dune, the Seven Kingdoms, and many others.

My latest discovery is *The Broken Earth* Series by N. K. Jemisin (published 2015-2017.) Jemisin's world is a chaotic, cataclysmic one in which seismic events occur like the seasons—and are called seasons, but these are seasons that last decades,




even generations, akin to "the end of the world as we know it." The volcanic events that strike the Stillness, as Jemisin's world is called, can be modulated or sometimes negated by the special gift of those inhabitants known as Orogenes. These people have the power to tap into and harness the volcanic forces within Father Earth, as she calls the planet. As powerful as they may be, Orogenes in Stillness are essentially the captives of the socio-political system established in the capital city Yumenes. Orogenes are feared by the majority non-gifted Stills in their communities as their powers can acci-

dentally destroy another person or an entire village. Orogenes are sought by "Guardians," who are trained to teach self-control to young ones and to guide them in the use of their powers. The Guardians seek to "rescue" child Orogenes before they can harm others or endanger themselves, and young Orogenes are trained in the Fulcrum, located in Yumenes.

That's just minimal background. Jemisin accompanies this intricate setting with an equally compelling language, societal structure, and culture. A cruel and harsh caste system has evolved in the Stillness, one into which each person is assigned at birth. Abuses of power, greed, inhumanity, privilege—all converge in Jemisin's world as readily as they do in ours. Her work in establishing a believable postapocalyptic world is masterful, and while magic is one of its major components, its human relationships, emotions, and motivations remain supremely realistic.

The Fifth Season, the first novel in the series, is the only one I have completed, but in itself is a marvel. Jemisin introduces her world in this

novel but skillfully combines her fantasy elements with a solid knowledge of geology and rocks—the science part of science-fiction. The story line traces the journey of a secret Orogene named Essun, who is searching for her husband



and daughter, after a world-ending cataclysm. Along Essun's route, Jemisin's world becomes more detailed as other fantastic beings and powers are revealed. But it is not only Essun's story we follow; her chapters alternate with the stories of Damaya and Syenite, two more Orogenes. It is not until near the end of the novel that the reader understands that these three women are one person at different stag-



es of her life. This narrative perspective is amazingly well-done; although some clues appear, it's a lovely surprise. Essun's journey is a dangerous, magical, and fantastic one that ends with a literally earth-shaking increase in her powers, but without her finding her daughter. Essun survives to continue her search in volume two of the series, *The Obelisk Gate*. I've already begun reading!
