Sometimes we over hear a conversation or are privileged to be part of the conversation and we learn a little more. Point is you become closer. And it seems we are all paying more attention to our friends and neighbors It is a nice thing.

One of the responsibilities of this office is to instill and pursue that the rules of the community are being respected and honored. ber of days to correct the problem, this office will be enforcing those dates and returning for second and third inspections. Residents who do not comply and have not notified the office as to the issue will be given a <sup>U</sup> Notice to Cure".

Residents are tired of looking at your junk, please clean it up!

- ♦ This office was notified by one of the local EMT's who came into the community they could not find a home due to the numbering, so please look at your house numbers ask yourself are they visible and can you see them at night?
- ♦ When receiving a violation for your driveway. Please try to pressure wash it first and if it does not look acceptable paint it but remember the colors must be approved by the office prior to painting.
- ♦ Any time you are painting your home again the colors must be approved through the office even if the colors are the same.
- ♦ We are all aware we have had a couple of homeless people trying to keep out of the cold and rain staying under the deck at the pool area. If you see a stranger remember to phone 911. If you see something suspicious please phone 911. We have purchased additional lightening for some of the darker areas of the park and they will be installed next week.
- ♦ Also, we have had some vandalism in the park with someone driving through and picking up various items from outside. Now we believe it is an isolated incidents however, please bring anything valuable inside or lock it up. We have asked for additional policing during midnight until 2 am. Again, if you see something suspicious call 911.



- ◆ NO parking at the clubhouse by residents overnight unless approved through the office. During the winter months we are busy with activities and need all the parking we can get. Your cars are not supposed to be parked at the clubhouse anyway just because your driveways do not accommodate two vehicles.
- ◆ Cat's Cat's Cat's! Caught 3 coming for yours! You will not get them back! And I am getting sneaky!

Just a heads up! I am going through past 360 inspections to see how many violations per each home have ever been corrected. And if you have been violated for something and did not correct it will take that seriously and address it seriously.

The annual HOA meeting was held on January 8<sup>th</sup>, 2019. A quorum of 84 households was in attendance. President Sandi Serdar reported that several items have been accomplished this past year in co-operation with the LST management including: New flags purchased, Pampass grass removed at Eden and Sunrise, Dead Century Plant removed, Sink hole repaired on Wintergreen, new street grates on Wintergreen, new perimeter fencing on Lake Griffin Drive and Wintergreen, new keylocks on clubhouse entrances, more speed limit signs in park, sealing of wood decks and posts in marina, and solar lights added to the pier.

Lots of discussion by residents of future needs were held and then passed on to the LST manager and the District manager at an Executive Board meeting. Results of that meeting included: Police will patrol more often, add lighting to Grove Street entrance, adding ground cover to front entrance, give attention to water fountains, redo pier sealing if needed, adding more fire extinguishers to the dock slips, remove dead tree from the marina walkway, upgrading with paint or vinyl fencing in pool area, getting more and better pool furniture, continue removing feral cats from the park, new high riser toilets for clubhouse, and remove unlicensed car from Eden street parking area. Next HOA open forum meeting will be at the clubhouse on Saturday, February 2<sup>nd</sup> at 10am. All are welcome.

need. That is one of the benefits of living in such a Great place.

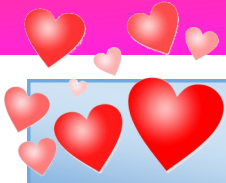

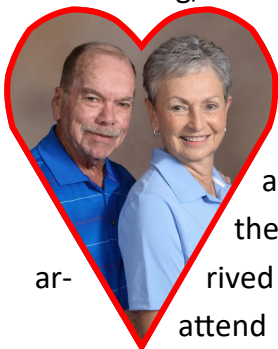
## Valentine Traditions

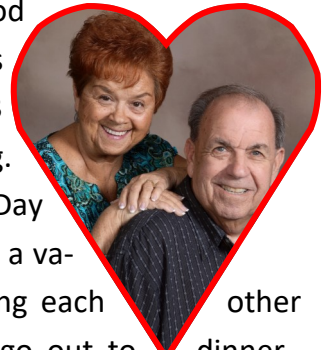

As he grew up he was bullied by his older step-brother and he learned how to make and use a sling shot for a weapon against his brother to defend himself till he got stronger and bigger.

He never did get along with his cruel mean heart-ed stepmother so he packed a small box of clothes and left home at the young age of 14yrs., and hiked to Mecca, Indiana to live with his Aunt Alice and Uncle Bill.



Uncle Bill showed him love, affection and gave him a loving home. At the age of 15 he worked with his Aunt at Turkey Hill State Park as a janitor and a repair man. Rus was very handy with his hands and could fix almost anything. He worked there till he was 19.

Nancy worked for K-Mart for 22 yrs. and was offered a job as a store manager but turned it down when she learned that they could transfer her to any location in the country. Nancy changed careers and started working at Disney World for 13 years until retiring at 76.

Rus and Nancy bought a home here at Lakeside Terrace in 2014 and Terry and Sandy followed his parents to this park in 2017, so he could be with his father. Rus liked this park cause of the location, reasonably priced homes and Lot Rents. They love the friendly and caring neighbors.

On Sept.3, 2018 (Labor Day), Rus tripped and fell in the living room of son's home and hit his head into the couch. He got up on his feet and walked across the street to his home. After x-rays determined that Rus had a broken neck he was transferred to a trauma center in Ocala on the September 6<sup>th</sup>. They transferred him to Lady Lake Rehab Center for 2½ weeks. Rus developed blood clots in his legs. At that time Nancy decided to move him to North Campus in Leesburg from Oct. 17<sup>th</sup> till Jan.7<sup>th</sup> (13 weeks).

Since being home Rus and Nancy have experienced kind, loving, and caring neighbors that have brought over home cooked meals to them, and helped watched Rus while he recuperates at home.

## A Reader's Corner

For me, the winter is always a great time to “curl up with a good book.” February’s books are both novels, one historical in nature and the other more lighthearted and contemporary.

### ***The Girl with a Pearl Earring* by Tracy Chevalier**

Basing her story on the famous painting, the author imagines the life of the young girl so beautifully portrayed by the artist Johannes Vermeer as *The Girl with a Pearl Earring*. Sixteen-year-old Griet begins work as a maid in the home of Johannes Vermeer and his family. She is anxious about



leaving her loving Protestant family to work in a Catholic household, but her father’s accidental blinding forces her to accept a role as one of the family breadwinners. She is quite good at the tasks set to her—one of which is to clean the famous painter’s studio—and she becomes an important contributor to the Vermeer household. As Griet’s position develops into one of some influence and authority, she attracts the attention of the painter himself. Vermeer becomes both a father-figure and would-be lover to Griet, eventually making her his assistant, a position of some intimacy. As her relationship with Vermeer deepens, Griet must contend with the reactions of his wife and family, even as the household is forced to accept the growing intimacy between Griet and Vermeer. As an available young woman, Griet has also attracted the attention of the young butcher Pieter whom she meets as part of her household duties. But Griet’s introduction to the more privileged class and higher economic status of the Vermeer household causes her to reject Pieter’s attentions and working-class lifestyle. Soon, Vermeer’s wealthy and older patron notices Griet and

demands a painting of her. Vermeer’s execution of Griet’s portrait causes tension and conflict in the home, however. The painting is the turning point for Griet as she is forced to choose between her ambiguous relationship with Vermeer and a future as a young wife and mother. The novel’s concluding section shows Griet’s life ten years later at the time of Vermeer’s death. The characters in Chevalier’s novel are interesting and sympathetic. Interactions between Griet and Catharina, Vermeer’s constantly pregnant wife, illustrate the position of women in the times. Griet is a maturing young woman, but at sixteen, still a child, and her relationships with the Vermeer children develop this innocent side of her character. As a servant, Griet must always remember her place, even though the master exhibits a growing fondness for her. Chevalier has created an intelligent, perceptive, and sensitive character who wants to control her own destiny but is hemmed in by gender, class, religion, and circumstance.

I generally like historical novels, so I did enjoy this one. The depiction of daily life in the mid-sixteenth century was fascinating, as was the view of women. The female characters are really the focus of this novel, which seems ironic given the male dominated society of the time.

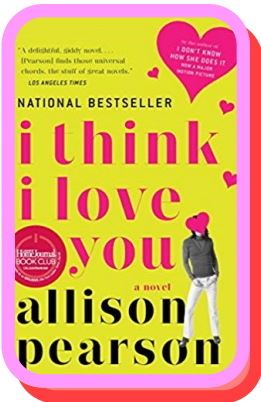






## ***I Think I Love You* by Allison Pearson**

In her novel, Pearson uses an alternating narrative technique, switching between the lives of Petra and Bill. Petra is a thirteen-year-old Welsh girl who, with her best friend Sharon, shares an obsessive crush on David Cassidy of Partridge



Family fame. Petra and Sharon struggle through the typical agonies of early teen-dom in school with classmates and at home with parents. Their only solace is their shared “love” for David Cassidy. They buy all the teen magazines and even enter a contest to win a visit with their idol. Although they receive

no reply from the magazine sponsoring the contest, the culmination of their Cassidy worship occurs when they attend a concert at White City Stadium in London. The reference to the concert is historically accurate; a young girl is killed in a crush of fans surging toward the stage. David Cassidy ended his teen-idol career as a result. Parallel to Petra’s and Sharon’s struggles is Bill’s story. He works for the magazine sponsoring the contest to win a visit with Cassidy. However, his job is demeaning and demoralizing; he must answer Cassidy’s fan mail and write the stories and releases purported to come from the star himself. Bill longs for a “real” position as a writer and journalist and hides his actual assignment from his girlfriend and others.

The second part of the book is set twenty years later. Petra and Sharon are married with children; Petra on the brink of a divorce and faced with the death of her parents. Bill is now the manager of several magazines and divorced himself. Going through her late mother’s belongings, Petra discovers a letter addressed to

her that her mother had hidden away. Petra won the contest that she and Sharon entered. Determined to claim her prize, Petra contacts the magazine and is invited to Las Vegas—with Sharon—to meet their idol. The plots and characters come together in the states with Petra and Bill forging a new romantic relationship.

Pearson’s plot may be a rather predictable romance, but her depiction of Petra and Sharon in early adolescence is dead on. I am a little old for teen magazines like *Tiger Beat* or *Rave*, but I watched my sister Elyse (60 Eden Drive,) my daughters, and even my granddaughter crush on their heartthrobs. Likewise, the novel is honest in its view of the adult situations facing the grown up characters.



I don’t know how old you were in 1974, but I was a young-ish mom with two kids. Nevertheless, I knew who David Cassidy was. He may have played a teen on television, but he was in his mid-twenties himself, and he had his own kind of deliciousness. By the nineties, I was also a divorced woman with teen daughters, hoping for a second chance at happiness. I could easily relate to this entertaining novel and enjoyed it quite a bit.

## Until Can't Becomes Can

There is a saying that goes "If everyone put their problems into the center of a room and each person had to pick one, most would gladly take their own problems back".

At 21, I got my very first apartment. It was efficiency, The living room/ bedroom held a sofa bed. To me, it was a sign that I had succeeded. My folks, who I still cared for daily, were only yards away.

I knew the owner of the building and one day he knocked on my door. He told me a lady had applied to be a resident but, he had concerns. Knowing I had experience dealing with handicapped people, he asked me to come out and meet her.

Carol was about 45 years old. She had a Guide Dog. Yet, blindness was not her only issue. She had been born deaf also.

She stood outside my door with a kind of typewriter which hung around her neck. To communicate, I typed a message, introducing myself. The machine wrote out my words for her in Braille. I told her I was happy to have her as a new neighbor.

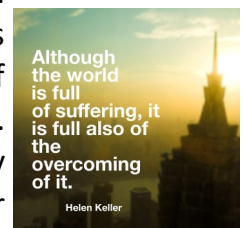
She asked me if she could have my phone number and she gave me hers. Her voice was a bit odd. If you have ever heard a deaf person speak, you know what I mean.

I told the landlord I would be happy to assist her if needed and would keep an eye on her. So, she moved in.

Her head was bald due to a surgery she recently had. She was one of the first to undergo a cochlear implant. There were great hopes that

this would restore at least some of her hearing. Yet, it was too soon to know if her operation had been a success.

There is a special service provided by the phone company to assist hearing impaired. Her Guide dog, Mia, was a beautiful German Shepherd.. When her phone rang, Mia would signal her in a specific way so she knew there was a phone call. Likewise, for the doorbell, smoke alarm etc. A few days after our meeting, I called her. To call a deaf person, one must first contact a TTD operator. The operator places the call and everything I said was sent to her in Braille. With the help of the operator, I told her I was going to the store and asked if she needed anything. She then typed her response to the operator and she verbally conveyed Carol's response to me. During our chats, I thought of Helen Keller. Helen was asked by a reporter once, what she thought was the more difficult handicap, blindness or deafness. Helen said not being a hearing person was harder because of the isolation of not being able to communicate. She felt she was often ignored by people who were intimidated or unsure how to approach her.



Carol had a grown son. He was a productive working man and she was very proud of him. She was a single woman and had raised her son alone. Pause for a second and think what that must have been like. Imagine, not hearing your baby cry or not being able to watch him grow. Despite this, she was always upbeat. She called me one day to say she had been in a car accident. Not seriously hurt, she asked if I would get her some Epsom salts to soak in. I asked how the accident occurred.. She solemnly said, "It was all my fault. I shouldn't have been driving." Her sense of humor was awesome.

What was the most amazing to me was her atti-



tude. She NEVER complained. She did ask me if she looked ok with her hair shaved off. Despite all her issues, like any other woman, she wanted to look attractive.

She worked for an agency that aided newly blind adults to adjust. Cooking meals, using techniques, many of which she developed. She abhorred the word "can't". When a new student told her they couldn't do something, she told them they could. If things didn't work one way, try another and keep trying until 'can't' became 'can'.

About a year after our initial meeting, she called with exciting news. A wealthy family in Connecticut had a child that was also blind and deaf. Would she consider coming to teach the child and live in the mansion? The staff would be at her disposal and the money was phenomenal! I was thrilled for her. Although I had total confidence in her abilities, it put my mind at ease to know others would be living with her.



.After all these years, I still think of her frequently. Even though we lost touch, she is still one of those people who left a lasting impression on me.

I hope wherever she may be, that she is happy and inspiring people the way she did me.
