This information was extremely useful for both Veterans and Non -Veterans. During the FMO portion of the meeting, they discussed how the Tie-Down program is progressing throughout the State of Florida as many parks have yet to be done. They suggested you hold on to the certificate that you received (if you got one last year) because the way the insurance companies are reacting about roofing, you never know if they will require proof of tie-downs.

They also discussed proposed bills that are still in the committee stages regarding the elimination of the sales tax on the re-sale of a mobile home and limiting the time allowed for a mobile home park to approve a new resident to 15 days. These bills are not possible without the input of the FMO. Keep in mind what the FMO can do for you. When FMO was able to help stop the proposed sales tax on our lot rents, that would have cost everyone in Lake Terrace in additional \$30.00 a month.

Author Delia Owens wrote "Where The Crawdads Sing" in 2018. This was written as a mur-

der mystery novel, set in the North Carolina bayous.

1952: Kya (given name Catherine Danielle Clark) is the youngest of five siblings in an isolated marsh. She watches as her mother leaves



the marsh with suitcase in hand. Her mother has left because of the abuse of her husband. Her mother does not return. Slowly, one by one, her siblings also leave, which leaves just Kya and her father.

Her father temporarily stops drinking and Kya learns how to fish and get food and plants to sustain herself. Her father gives her a knapsack so that she could collect shells, marsh creatures, and also feathers from different birds. She starts doing paintings of these with the watercolors that her mother left behind.

One day she finds a letter in the mailbox. Her father snatches it from her, reads the letter, becomes infuriated, then burns the letter and most of his wife's belongings. He returns to drinking and takes long trips to do gambling. Eventually, he doesn't return at all. Kya assumes he has died.

Thanks to her relationship with nature and the kindness of Jumpin' and his wife Mabel (a black couple) who run a gas station and store at the

boat dock in town, she survives and sustains her life alone in the marsh.

Kya becomes known as the Marsh Girl. She attends school only one day. Embarrassed, she never goes back.

She's befriended by her older brother Jodie's friend Tate Walker. He teaches her how to read and write, and eventually forms a romantic relationship. When he leaves for college, he promises to return to Kya, but, while away, he realizes that she could not adapt to his social world and he leaves Kya alone with his broken promises.

1965: Kya is 19 and still ostracized. The star quarterback of the high school asks her for a date. He tries to sexually assault her and she runs away. He apologizes and she gives him another chance. They date for a year and Chase tells her he loves her. Kya makes a necklace for him, a distinctive shell she found and hung on a rawhide string. He wears it every day. Thinking he was intending to marry her, she goes away for the weekend with him and sleeps with him. Shortly afterwards, she sees an announcement in the paper about his engagement to another girl. Kya ends the relationship.

When Tate finishes college, he comes back and confesses his love for Kya. She rejects him. Seeing her collection of shells, he encourages her to write a book. Working with her, she publishes two books on seashells and birds of the marsh, earning enough money to pay off taxes for the house and land and renovate the cabin.

Three years after their last encounter, Chase



confronts Kya, intent on continuing their affair. She refuses, he beats her, and again attempts to rape her. Two men witness the attack, but Kya knows the town won't take her side. A few weeks later, Kya is invited to an out-of-town meeting with her publishers. During her time away, Chase is found dead in the marsh, lying face up at the base of the fire tower where he had once taken Kya on a date.

1970: Kya is tried for Chase's murder. The sheriff and deputy find clues and townspeople tell them about the assault on Kya. They believe she killed him out of revenge. Shoddy evidence is given at trial and she is found not guilty. Tate and Kya become lifelong partners and live a full life together. She dies at age 64. Tate discovers

a cache of poems written by A.H., who turns out to be Kya. One is a description of Kya murdering Chase. Tate burns the poems.



"Marsh is not swamp. Marsh is a space of light, where grass grows in water, and water flows into the sky. Slow-moving creeks wander, carrying the orb of the sun with them to the sea, and long-legged birds lift with unexpected grace — as though built to fly — against the roar of a thousand snow geese."

Many people at the book club expressed their reasons for liking / not liking the book. Some people said she murdered Chase out of revenge; others said she murdered him for self preservations. If you read the book, you may form your own opinion. Mine was for self-preservation.
