# Heater and Air Conditioning Emergency Unit

Lakeside Terrace Residents,

The Social Club and HOA boards have joined together to purchase a portable heating - A/C unit to be used if yours fails. Carol Roberts initiated this process when a neighbor's A/C went out. Luckily, they were loaned a window unit to tide them over. The two boards brainstormed and came up with this plan.

This portable unit weighs about 70 lbs. and is on wheels. It's stored at Carol Hetherington's. We have a team of people who are familiar with the unit and can assist in setting it up if you need help. It really is pretty easy to set up. This will give you a little cushion while you get repairs. After only about 6 weeks the unit has already been used 3 times - and those folks are happy!

Here's a copy of the consent form to sign when you take it:

# **Consent for Use and Liability**

The Lakeside Terrace Social Club and HOA boards are **loaning** you an air conditioning and heating unit for use in your home. The loan is taking place due to the malfunction of your central system. It is only a stopgap measure while permanent repairs are completed. This is expected to be a short-term loan.

You are expected to return the unit in good working order, and to care for it properly while it's in your possession. You need to show a representative of either of these organizations that the unit is working properly before disconnecting and returning it. By receiving this equipment, you accept full responsibility for it, and for its use.

Dear Lakeside Terrace Residents,

Is it Feb. already? Wow! 2024 seems to be going by quickly and so much has happened already this year.

This month I want to focus on protection and provision. First, I have talked to some of you already, but I want to make sure that EVERYONE is checking their accounts and that the appropriate people are in the correct If you have a spouse, partner, places. or even a child that would need to be an authority over financial payments, decisions, or stay on as a resident of the park after you leave or are gone, please make sure that they are on the LEASE as an APPLICANT. If you need additional people added to your leases to protect them, please see me to get background and credit checks run on them. Let's get them added to your lease. ONLY applicants can pay rent and are responsible for the decisions made within the community. Occupants have no say so and can be removed from the property if an applicant leaves or passes away if they do not pass a credit check alone. Also, if you are adding anyone to your titles, please make sure I have an updated copy.

I'm also asking that everyone make sure that I have your correct phone, email and mailing address contact info in my system. I want to be able to communicate effectively with everyone and need to know that if I send an email, a letter, or call that I am reaching out to the right person. I am working right now to set up my emails and my multiplier call system to be able to do this. I need your help for it to work for both of us.

It has been a concern of some of the residents of a possible rodent problem in our community. Randy Ellis, Ron Grove and I got together to brainstorm ideas and solutions. The conversation was quite beneficial. So, focusing on all of us working together to ensure that this isn't a problem is where I want to put my energy. Rodents are always

looking for food, shelter or water. One of the most common causes of infestation is leaving out food. So, I am asking that ALL residents keep your outside trash or water in closed containers, and do not put or leave any food outside of your home. Be aware of any holes in floorboards or walls and do your part within your home to remove any opportunity for any shelter to be found by an investigative creature. Some all-natural suggestions to use are peppermint, cloves, cayenne pepper, chili powder and even cotton balls soaked in vinegar. We are putting out traps around the property to help prevent the problem as well as keeping all water & trash in closed containers and any holes blocked from entry. We, the ELS team, are putting in the same effort and action as we are expecting of you. Let's keep this from being a problem TOGETHER!

Lastly, I want to tell you that I'm fully aware that hard times can happen to all of us. I know the groups of the community are here to look out for your best interests and they do such a great job. We at ELS also have an opportunity to help those in need. There is a Financial Hardship Program we offer to those that qualify. If you have had a life changing event, have lost a source of income, or are barely making ends meet, you may qualify. If you are interested in seeing if you qualify to apply, come see me for the screening questions. I would love to see if this is a resource that could help you.

I feel like we are doing a great job at working together and moving forward into this new year! Thank you for your participation! Let's keep it up!

I'd like to thank everyone for participating in our Annual Mtg. Jim Filbert and Carol Roberts were both elected to 3-year terms. I would like to thank Scott Greer for stepping up as well for being a candidate. I also

want to thank everyone for overwhelmingly approving the additions to our HOA's By-Laws. The 5-person HOA Board is Randy Ellis, Pres.; Carol Hetherington, 1st Vice Pres.; Carol Roberts, 2nd Vice Pres.; Jim Filbert, Treasurer; and Will Johnson, Secretary.

On Jan. 3rd, Ron Grove and I met with Park Mgr. Malinda Brown to see if we could help solve the rat problem inside the Park. She confirmed that all signatures have been secured re: Clubhouse Reno. During the Park Mgmt. mtg. last Oct. it was revealed that renovations are so extensive, ELS estimates that the Clubhouse may have to be closed for nearly a year. Tom Wetzler (ELS District Mgr.) said that Negotiations would likely be necessary this coming year. Concessions will have to be made on their part due to the potential Clubhouse Closure. At the Annual Mtg. I also brought up the need to strengthen our Negotiations Committee. Another request from the HOA to Park Mgmt. was to get copies of bills re: Water, Sewer, and Trash Removal. We've begun to receive copies of some of the bills. Malinda has kept their good faith, and she's working on completing this task.

In addition to the Clubhouse Reno, we discussed House Bill 613 and 2 different opinions between the FMO and the NFP ("Networking for Progress"). I posted the differing opinions along with the Nelson Procedure (ELS' complaint procedure) on Facebook and in email. We also discussed a possible merger between ELS and Sun Communities. I feel that the communication between the HOA and Malinda Brown is going very well.

My 1st year as the Pres. of the HOA was a complete learning experience. As most people know, I communicate using Facebook and Email. If you are not on Fb or do not have an email address, and would like to receive a hard copy of my communications, please get a message to me. I will do the best I can to provide you with such. There are Resident Information Forms at the Clubhouse for anyone who needs to update their personal info with the HOA. We also have a new Comment / Wish List Slip at the Clubhouse. The HOA has a locked box at the Clubhouse where anyone can submit these forms or slips.

If anyone has any concerns or questions, please feel free to contact me anytime.

#### **FMO District 3**

#### Dear Friends and Neighbors,

As a resident of our community, I have become increasingly aware of the importance of our park HOA; and now more than ever, the state HOA, the Federation of Manufactured Homeowners of Florida (FMO). The FMO has been in existence since 1962, protecting the rights of Manufactured Homeowners.

The FMO has an office in Altamonte Springs with a staff who attends to the administrative duties of membership renewals, accounting, communications, and scheduling meetings for District and State Boards of Directors. In addition to advising organizations of Legal Matters, the FMO has an Attorney who answers members' questions pertaining to your park. One of our most important personnel of the FMO Team is our legislative consultant who is in Tallahassee. To keep you informed, she publishes a newsletter, "The Watchdog" that is emailed to members. Our organization also has a Board of Directors, District Presidents, and Park Representatives who report to the homeowners.

In order to continue our protection of our rights, we need your support by joining the other FMO Members of our community. Please look over this article completely and join the FMO by calling the FMO Membership Services at 321 - 214 - 4300 or go to fmo.org to join. FMO Membership is \$30.00 for one year or \$75.00 for 3 years (per household). You may also contact your park rep to assist you so we can continue to hear your concerns and protect your rights as manufactured homeowners.

What would happen if we did not have the FMO and Florida Statute 723?

Some of the Items are:

1) There would be no HOA as it stands presently.

2) There would be no power to negotiate with park owners.

3) You could be evicted with a 7 day notice.

4) Rents could go up with a 30 day notice every 60 days with a 30 day notice.

5) In regards to rents, etc. check 723.031, .033.

Remember: The FMO is an organization in the State of FL that watches over the interests of people living in manufactured homes. FL is also the only state where those living in manufactured homes have laws that guarantee them the rights of their lifestyle.

The Florida Manufactured Home Act (FL Statute 723) was enacted in 1984. In part, it addresses the relationship between the Park Owner and the Homeowner. The FL Legislature recognizes that Mobile Homeowners have certain basic property rights, which must be protected; also the Park Owners have certain rights that also need to be protected. They also are included in the law.

FL Statute 723 is updated frequently to keep it abreast of current situations. You can go to MyFlorida.com and put in Florida Statute 723 in the "search bar" and read it or print a copy for FREE.

It covers such items as:

1) Your Prospectus

2) Failure of a Park Owner to provide a Prospectus

- 3) Park Owner's Obligations
- 4) Rules and Regulations
- 5) Dispute Settlements
- 6) Evictions, grounds and proceedings
- 7) Lot Rental Increases
- 8) Reduction in services or utilities
- 9) Changes in Rules and Regulations
- 10) And much, much more.

The FMO is available on your computer at www.fmo.org. Information is available about

the FMO and various programs. There is also a "Storm" section which contains some of the most comprehensive information available on the web for Manufactured Homeowners on what to do in case of a storm.

FMO: Why Join?

1) Passing of the Florida Mobile Home Act (Chapter 723) which protects your rights as Manufactured Homeowners.

2) Our Legislative Counsel successfully kept the Tie-Down Program for ten more years.

3) Requires Citizens Insurance to cover Mobile Home Attachments (Sheds & Carports).

4) Defeated multiple attempts to add a 7% sales tax to our lot rent.

5) FMO Political Consultants in Tallahassee monitor proposed legislation that may be harmful or beneficial.

6) Our FMO Staff in our Altamonte Springs office are there to take your calls and help you with your concerns.

7) District Meetings where members congregate to discuss issues in their parks and have informational guest speakers.

8) "FMO Magazine" is published bi-monthly with legal questions, legislative updates and articles of concern to our members.

These are just a few of many reasons why you should join the only organization that protects the rights of Manufactured Homeowners.


