normalcy and still maintain social distancing. We together have worked to keep each other as safe as possible. Thank You! And still, we have those who do not wear a mask, those who are asymptomatic, those who walk around not knowing they have the virus but still socialize. Please be careful! As a community we are in this together.

We now have more than a few residents who have tested positive for the virus. As you know all the amenities have been closed except for the pool and spa. These amenities will remain closed until we feel that it is safe for the residents and then we will reopen. I am anticipating the end of January 2021?

I will begin the 360 inspections hopefully within the next 2 weeks. Remember to remove the items laying outside and around your home. Nothing should be on the ground outside except for your trash cans, and lawn furniture. NO tires, boxes, old paint cans, mulch, gravel, rakes, potting soil, planting pots etc. Nothing outside. Nothing on your driveways other than patio furniture. Remember to pressure wash your home and driveway, and clean any lattice work you have hanging.

- Remember when selling your home by owner or by realtor to let your buyer know about the pass thru taxes and renewing your mobile home license. Remember if you are the seller to notify the office if you are on EFT and are about to close on your home or are selling it.
- ELS rules for compound, slips in the marina or storage area require a 30-day notice of cancellation. If a 30-day notice (hand written or emailed) is not given within 30 days, the contract for the storage or boat slip will remain on your ledger until the notice has been properly given. If the key to the storage compound is not returned your ledger will be charged \$35.00 per month until it is returned.
- I have seen increasingly motorized 2-wheel bicycles or forms of transportation which are not a moped and have not been approved to be in the park by this office. Whoever that is, please contact the office at once.
- Remember, I realize there are so many changes to our lives lately. However, if you have anyone in your home for more than 30 days and have not had them park approved then please contact this office. In addition, if you are not on a lease and the primary leaseholder moves, vacates, or passes away it is

your responsibility to notify the office and process an application to approve you as the new lease holder.


- Our projects for this year are as follows: To pave 3 old roads, to rebuild the deck off the clubhouse, to enlarge the lounging area at the pool and to add a new commercial grade fence with automatic locks around the pool area. As you know these items will be worked on over the months. You know I do not know when these will be scheduled. There are lots of things to do to get the process started but when I know you will know.
- We do have new residents on Lake Griffin who are deaf. A sign has been added, so please slow down... they cannot hear you.
- I hope the rainy season will be starting soon and it has always been a dream of mine that those who do not edge their driveways, or around their trees, rock gardens and along the road would begin to. It is such a nice clean look and makes the park look so professional.

I want to share something with you. I have been the Community Manager here at Lakeside Terrace since 2010. I have worked with the Social Club for 10 years. The Social Club cannot take credit for some of the things they have accomplished by thinking and acting outside of the box. Happy New Year, I truly hope everyone does have a Happy New Year but let's be honest, it ain't starting out that way. Currently we are still dealing with the COVID-19 virus and it is affecting all of us in various ways. The biggest is just the way we interact socially. For Christmas my wife and I pretty much just did the video Christmas. Not the same as being able to spend actual time with family but for everyone's health we really couldn't risk it. Everyone had high hopes that the vaccines would provide a big change. However, I have to say that the roll out, at least in Florida, could have gone better. I know many of us are searching for a list or a location where we can get vaccinated, if not for ourselves then for someone we care about. Frustrating is putting it mildly. Speaking of Covid, I know there are opinions all over the spectrum as to the seriousness, prevention, mortality, how infectious it is, etc. I know several people in the medical field. They all stress that this is serious and getting worse. Locally I recently had the opportunity to speak with a Hospitalist at a local hospital. For those that may not know, a Hospitalist is one of the Medical Specialties. The easiest way I can define them is, they are the General Practice Doctors who work the Hospital floors. This local Doctor staffs at a couple of the local Hospitals. He told me that currently he is seeing about one death every four days related to Covid. He also told me that the problem isn't so much the mortality but that the Covid patients are filling up the Hospitals. At one hospital he works he has had a patient housed in the Emergency Department for two days due to no bed space. This patient was being treated for a stroke. So, serious health conditions may have difficulty finding bed space. Please, for the foreseeable future we will be wearing masks and social distancing. No matter what your opinion it's for the safety of your family, friends and neighbors, take this seriously. OK, now to HOA business. The Board meeting for December was adjourned due to lack of quorum. I want to clear up one misunderstanding. IF you have your name on a title for one of the Homes in this park you are a MEMBER of the HOA. This HOA charges no dues and requires very little from our members. We would like to know who you are though, if you don't mind. So if you are not getting information from the HOA via e-mail please send an e-mail to lakesideterracehoa@gmail.com Each Home gets one vote, if we can ever get a chance to vote on anything. Normally, in January is the Big General Membership Meeting. For us to have meeting with a quorum our current By-laws requires 60 members to be present. I did have a suggestion recently that we could have an outdoor meeting. I know they meant well but short of having the meeting in the storage yard with a PA and speakers I don't see that being logistically possible. Also at this meeting we are suppose to select new Board Members and other corporate functions. Obviously we won't be having this meeting this month. Florida Statutes allows us to amend our By-Laws with an Emergency clause whereby we can enact a "Stand in Place" policy. Basically, everything stays the same, Board officers, Budget, etc. until we can hold a meeting. If this lasts 'til summer we will be pretty hard pressed to have 60 members in the Park. So personally, I don't see a General meeting till the fall at the earliest. Now, recall earlier in this paragraph where I said "we don't require much from our members"? Here is the little bit we do need. One of the big items on the HOA's jobs is to negotiate with

law, practice and proper form for our

Management on the issue of Rent in-

creases. Every year we have the Right by statute to meet with Management and discuss a Rent increase and review their basis for the increase. To do this our By-Laws specify a Negotiating Committee. This committee would be asked to research tax increases, other park comparisons, amenities, change in costs etc. Then in the fall, when notified of the anticipated increase, file a demand to meet with Management. I haven't researched the history that much but in the years that I have been here I don't remember the Members ever meeting with Management. So, to put it briefly, we are looking for anyone in the park that may be interested in helping in some way. Members with knowledge of property management, tax, business or even just an interest in giving it a shot. Please contact me or any Board member and we can answer questions and provide assistance for some information and training. We would like to be rolling by March and much of this can be done via email and video. You don't have to be a full timer. During our January Board meeting we covered a few items. First and I do mean literally a first was a budget. OK it sounds a lot more impressive than it is. According to our By-Laws we are required to have a budget and this budget must be approved by the General Membership, that damn voting thing again. Anyway our brand, spanking new budget is pretty much just our current assets \$10,340.65 in C. D.s and \$6,613.02 in checking. Expenses, State annual filing fees and \$300.00 in operational or office expenses. We have no predicted Revenue except \$0.65 in Checking In-

terest. Basically the same as last year, if we had a written budget last year. The Board will begin working on a completely new set of By-Laws, basically to bring our current By-Laws to better reflect current

type of Corporation. When complete, the draft By-Laws will be sent out to the membership for comment and then presented for a vote either in the fall or at the January 2022 meeting, even if we have to hold it in the storage yard. Now, lets go back to that "we don't require much from our members". Yearly, we solicit for a list of "Wants" or Wishes" that we present to Management for their planning and budget. Please submit your ideas either by e-mail, to a current Board Member or in the HOA mail box in the Club House, if we can ever get in. Yes, the request for a Pub in the Club house will be resubmitted for the 10th time. It is with great regret I have to report that our slightly famous, noble and rising star, Al Pearce, our 2nd VP has tendered his resignation. He will be missed. So, we need a replacement. Please consider volunteering. It doesn't take a lot of time. A little required training, able to do e-mail, a few meetings a year and the desire to speak up and be heard. Again, send an e-mail, talk to a current Board member, or drop a note in the HOA Box. The pay ain't great but the glory and prestige! Well, what can I say. Usually in my member bulletins I try to add some levity to what is basically some pretty dry and boring stuff. I thought about it hard these last few days. I just can't do it this time. Last Wednesday I saw something that I truly never thought I would ever see in my life. The "event" we

RE-Turnin' Pages

What happens when your family takes you north for six weeks . . . Yep, I missed

a book club meeting or two, but reading??? Where to start? I think I read a dozen books: good, bad, and maybe even ugly. Two that I would recommend use two different versions of "time travel," one of my favorite devices in fiction, and one that was especially appealing as we counted down the minutes to the start of a new year.

In Oona Out of Order, by Margarita Montimore, main character Oona Lockhart experiences a "condition" in which she collapses and wakes up just after midnight in every new year, but Margarita Montimore in a different period of her life.


The event first occurs when she is eighteen. Oona is facing a decision in her life—should she study economics in London as she and her best friend have planned or should she stay in Brooklyn playing in her boyfriend's band, on the cusp of a big break. Oona's decision is taken from her at midnight; when she wakes, she finds herself nineteen intellectually and emotionally, yet living her fifty-fifth year, physically and financially. Oona-on-the-inside ages linearly from the age of eighteen while Oona-on-theoutside shows the age into which she has traveled. This random pattern continues throughout her adult life as Oona gradually learns to grasp the threads of continuity that exist through people in her life and to direct events by leaving herself letters each year. The plot points are moving and interesting, but the most significant ideas are the approach to the

nature of time. The novel addresses the idea that time is not an irreversible succession of events from past to present to future. Montimore hints at Einsteinian theory that time is not linear but is an everchanging now. This novel is entertaining, interesting, and clever-and presents an opportunity for philosophical consideration, too.

In Five Years by Rebecca Serle, presents another female protagonist whose life is dramatically affected by time, choice, and chance. It is a moving love story about five years in the life of Dannie Cohen, a high powered Manhattan lawyer who has everything she has ever wanted, whose life is unfolding perfectly. Dannie has planned her life out, deciding when to focus on career, when to choose to marry, when to build a family. But on the evening after she has secured the next step in her career, the evening after she has final-

ly become engaged to her longtime boyfriend, an exhausted Dannie falls asleep only to wake five years later, in a different apartment, engaged to a different man. An hour later, she finds herself back in her normal life, trying to shake off the effects of her disturbing "dream." Four and a half years later, she is in-



troduced to the man in the dream, her best friend's true love. Can she overcome her attraction to him? Can she prevent herself from breaking her best friend's heart? Real love is the theme of this novel and heartbreak is its shadow.

On Another Note...

It always intrigues me when I hear someone say the bible is boring and hard to read... I wonder if they realize that many of the movie plots that Hollywood produces come from the pages of scripture! The proverbial "bad guy verses good guy" story line that so many movies are based on comes directly from the Bible.

Take for instance the Old Testament book of Joshua. I love the stories in that book for several reasons. Let me recap

a story for you; many years earlier in the book of Genesis we find a man name Abraham. The book of Joshua picks up the story near the end of a forty year period of time that the "Israelites" had been "wandering in the desert" due to their disobedience and unbelief. And now after God had protected them and done amazing miracles for them out in the desert they find themselves once again on the boarders of the "promised land".

The great Jordan River is before them, and without a means to cross over, God performs the parting of the waters miracle once again for them so they can pass safely to the other side. They are then faced with the stronghold city of Jericho. This city was known for its huge walls and mighty men of war and godlessness. In order for the "Israelites" to move forward that city must be removed, but how?

God then gives the strangest "battle-plan" to Joshua, telling him to assemble a parade of priests and soldiers and march them around the city once a day for 6 days; and on the 7th day to march around it 7 times. On that 7th lap around the city they were instructed to shout praise to God. What a mission of faith this was, to praise God **before** the miracle happened! And of course you know the ending, the walls of Jericho fall and God's people move forward in victory! (see Joshua 1-6)

Dick Bird, 84 January 1, 2021 Formerly of Jackson, Mi. Lived at 19 Lakewood Lane


