
Turning Pag



A recent Ohio book club selection led me into literary territory I usually avoid. While I really enjoy historical fiction and often read nonfiction, biography (or autobiography) is not a genre I typically choose. Its fact driven base and narrow focus have, in the past, led me to dismiss it as either banal or narcissistic. However, when it is well-done, the narrow focus on one life can illuminate an important historical event or an entire age and offer interesting commentary on the times.

This month, I read Dayton native Rob Lowe's

first memoir, *Stories I Only Tell My Friends* (2011). I didn't expect much from what sounded like a Hollywood tell-all, but I was surprised that some of the book was interesting and entertaining. I had always dismissed Lowe as a pretty boy, a mini-



mally talented and somewhat narcissistic actor, but I began to admire him and his selfdeprecating manner as he worked in the sitcoms *Parks and Rec* and *The Grinder*. In both of these roles, he seemed to take himself less seriously and seemed willing even to laugh at himself. And I will admit that these qualities also show up in this memoir. Unfortunately, so does an element of self-absorption and pretentiousness.

The episodes of Lowe's early life with his par-

ents in Dayton, Ohio, give some insight into his character. After his parents divorce, at more than one moment, as a young man, he is supporting not only himself but also his family. After his mother moves him and his brothers to LA, he is tenacious in pursuing acting as a goal, traveling from audition to audition, alone by bus across town and back. His mother's struggles with depression often leave him and his brothers to fend for themselves, and Lowe is open and honest about his emotional struggles in the face of this situation. While he carefully explores his relationships with fellow performers, specifically the "Brat Pack," his anecdotes take on a namedropping quality as he leads up to the punch line - usually naming a very famous, successful performer whom he knew "back when." These include Daryl Hannah, Cary Grant (and his daughter), Janet Jackson, Tom Cruise, Patrick Swayze, Martin Sheen, John Belushi, Liza Minelli, Francis Ford Coppola, even JFK junior and Monaco's Princess Stephanie. The A-List mentions go on and on, and only serve to detract from his attempt to cast himself as an ordinary guy, just one who is extraordinarily good-looking and very lucky. (Lowe is quite honest about the impact of his looks.) Always willing to give one hundred percent to a project and to accept dubious projects to keep his career alive, Lowe willingly shares the ups and downs of his career, detailing the screaming frenzies of teen girls, the offscreen machinations on The West Wing, and the embarrassing final cut of *The Outsiders*. He is transparent about his addictions and time in



rehab, yet he barely mentions the well-known sex scandal involving a minor, and he even credits the scandal as the best thing that ever happened to him. His eventual success as a sober, happily married, fairly well-adjusted father of two is marred by this sort of narcissism. However, Lowe definitely is happily married, sober, fairly well-adjusted, and quite successful. The reader really wants to accept him and like him. And I admire his skillful management of a less-thanstellar career, his transformation of himself from sexy teen idol to serious actor to talented comic character. I wish Rob Lowe's memoir were a little more accepting of himself – he wants us to see his flaws and foibles, to understand him as a work in progress, just like the rest of us. But he can't seem to believe that that's what we want. So he gives us another character, one who says I'm just an ordinary, lucky guy, but who also has to impress us with his connections and brushes with fame. Stories I Only Tell My Friends is an entertaining story, but it's disingenuous to think that Rob and Lare friends.

Rob Lowe has written a second memoir, *Love Life* (2014). Other biographies I recommend are *Prairie Fires: The American Dreams of Laura Ingalls Wilder* by Caroline Fraser and *Mornings on Horseback: The Story of an Extraordinary Family, a Vanished Way of Life, and the Unique Child Who Became Theodore Roosevelt* by the inimitable David McCullough. Fraser's book is one that illuminates an entire age through the life of one struggling pioneer, housewife, and author; McCullough's gives the reader a com-

pletely unique portrait of a beloved and wellknown president through the eyes of his family. Both of these works complement the light treatment in Lowe's memoir. A biography reviewed in an earlier issue also deserves another mention: *The Good Neighbor: The Life and Work of Fred Rogers* by journalist Maxwell King.
