🧐. Masks must be always worn when entering the clubhouse and remain above the nose while inside the clubhouse.

🧐. Right now, the clubhouse is open from 8 am to 4 pm 7 days a week. Only 12 persons can be in the clubhouse at any given time. Only residents are allowed in the clubhouse or the pool area. The pool can only be utilized by 8 residents at any given time. We are in hopes as the winter residents return everyone is respectful of how many residents can be in the clubhouse or pool and find a way to allow other residents to enjoy what amenities are available to them.

🧐. Any activities changes must be approved through the office.

🧐. We will be beginning hopefully our 360 inspections in December weather and staff permitting.

🧐. Keep 6' social distancing at all times. Wear a mask and protect each other.

I am sure the Social Club will be updating residents with any changes in the Thanksgiving or Christmas availability.

Remember:

- ♦ Watch your speed.
- ♦ Pick up after your pets.

ELS just lifted the restrictions to evictions and evictions so look outside if you have stuff laying around in the back of the house or in the driveway/ Let's get it cleaned up. "The question as to the Covid guidelines has been raised not only to the HOA Board but to the Manager as well. Such as what guidelines, organizations etc. does ELS go by in the decisions being made which govern what Covid - 19 restrictions are being implemented at Lakeside Terrace? Yes, you do live in a privately owned park of which ELS are the owners. Their concern in this stressful period is for the residents' safety. They take many guidelines into consideration and implement their best policies to keep residents safe."

"Activities - Activities are scheduled by the Social Club. While being played within the clubhouse social distancing rules must apply. In the event an activity's participants cannot follow the distancing rules, either the game will have to be moved from the clubhouse to outside and or it will be canceled. New activities can be substituted within the social distancing rules."

I would like to add that Ms. Linda Neir has little input into what these guidelines are, they are a corporate decision. We also spoke to her about some of the potential changes /upgrades in the Park.

"Asset Management projects such as the replacement of the deck are controlled by ELS. Manager will share information as it is given. Capx projects for 2021 are the roads, enlargement of the pool surrounds and replacement to the fence around the pool area offering electric locking system"

The Pool bathroom opening is still "pending". Issues with contractors and inspections caused the delay. Covid has caused a lot of the problem. There was an incident where the bathroom fixtures were damaged. It happens, it is unfortunate. This is a good reminder to please use normal care, caution and awareness of your property and your neighbors.

I apologize for not putting out a newsletter the last couple of months. Things have been busy and not busy and well frankly you get what you pay me for. Now that November is here our "Snow birds" have started their migration. Home / Property Inspections,

"The HOA has requested to accompany Management during their home inspections. At that time, the manager or representative will explain what they look for and how the 360 inspections work in connection with days given to comply and how follow up is handled. "

"Effective November 1, 2020 ELS lifted their restrictions on COVID - 19 evictions and rule violations and at present can continue following the rules and regulations of Lakeside Terrace.

Regarding the Rule violations that may need to be addressed, we asked Linda for a short list of the most common ones that she is finding and is aware of, I received this from her Monday. *"A few of the major violations are as follows:*

- A. *Homes that require painting*
- B. *Pressure washing of driveways and homes*
- C. *Parking of any vehicle on the lawn*
- D. *Items being stored outside the home.*
- E. *Items on driveway and carport*
- F. *Signs in the yard*
- G. *Trees needing to be trimmed.*

Rule violations are not subject to just the home. It can be having an unauthorized unapproved occupant in your home. It can be parking a RV, or Boat overnight in your driveway. Anything that violates the rules of the community. "

If you need a copy of the Rules please contact the HOA Board or the Managers office.

The HOA Board is continuing its efforts to address its own issues regarding structure and By-Laws that have slipped past over the years. We did change the By-Laws to comply with current Florida statutes. However there are still deficiencies that need to be corrected. These issues pretty much require an entire rewrite of the By-Laws and a vote by the Park Membership to approve. The hiccup is because of Covid we can't

logistically have a meeting. An additional hurdle is the lack of many of our members being able to even make it to Florida. Now there are a couple of ways that this could be corrected if we could change the DAMN By-laws. One issue we are dealing with is an accurate members roster. We provided forms to every home in our park last spring. To date we have only gotten about half back. This information is what we use to contact the members about issues. Half isn't enough. We did correct one hangup. Management was supposed to provide the form with information to New residents moving into the Park. This has not been done in the past. We obtained assurances that this will be implemented by Management in the future.

This is getting to be long and boring but I felt it was important to get the information out. I will repeat an old request. IF you know of any resident in the Park that is not getting these Newsletters please, please have them contact the Board. We want to add them to the list. Some of the forms we received in the beginning were difficult to read. I am not complaining, my wife writes everything for me that needs to be read by someone. I can only read my writing for about 60 days then even I can't read it anymore.

So in closing, Please wear your mask, wash your hands, maintain social distancing and try to wear clean underwear. Not sure why, but my mother used to always say that to me when I left the house. I guess she knew I was going to get into a lot of crap when I went out.

bowling, cards, bingo, sewing, book club, and billiards returned to our agenda. Social Club, along with Linda and Nina, devised a safe schedule for our usual pastimes. The kitchen remained closed, so traditional celebrations could not be held. But on the upside, the kitchen remodel progressed smoothly and is on track to be complete with the delivery of two ranges in early December. We missed everyone’s birthday; **Fourth of July** meant televised fireworks on-your-own, and the **Labor Day** cook-out was put on hold—it was just too hot with no place to cool off. Social Club was able to put on a cookout for **Memorial Day**, although it was kind of a drive-through, walk-through affair. We held outdoor **Social Club meetings**, and will continue to do so. And by October, we had a groove going. Our usual clubhouse events have been re-booted to suit an outdoor location as much as possible. **Halloween** was a nice “picnic” with great prizes for clever and fun costumes. Martha and Laura engineered a way to thank our veterans on **Veterans’ Day**. Your own private family-and-close-friends gatherings will have to suffice this **Thanksgiving**, but we will give you some raffle prizes. Toys for Kids donations are scheduled for that event, as well. Certainly, more winter activities will be in the works.

Federation of Manufactured Home Owners of Florida

I have taken a much more active role in FMO this year. Besides being your park representative and assistant treasurer for District 3 (or area, Lake county) in the spring I became a Director of the state organization, a member of the political advocacy committee and this week will become chairman of the by-laws committee. It's been interesting!

First I would like to remind you of what the FMO is about:

The FMO is an organization in the State of Florida that monitors and advocates for the rights and interests of manufactured homeowners living on leased land. Through FMOs involvement, the Florida Manufactured Home Act (Florida Statute 723) was drafted and enacted in 1984. It addresses the relationship between the park owner and homeowners of manufactured homes on leased land. The Florida Legislators recognized that manufactured homeowners AND park owners both have certain basic rights that must be protected. The FMO and FMHA (parks owners) frequently submit changes to FS 723. FMO has had a huge impact on proposed legislation by opposing harmful proposed changes through negotiations. A key point from last year that got removed was a requirement that an owner selling their home must bring it up to code before selling it. That could hurt some folks very badly! The most recent direct financial impact for all of us was defeating adding sales tax to our rents and an amendment that would allow commercial property taxes to in-

crease faster – impacting what would be passed through to us. In the last election we surveyed every candidate to find and endorse those that are favorable to our life style and it helped a lot. Our local endorsed candidate was Brett Hage and he won handily – thanks!

FMO exists through membership. We need you to join! It's only \$25 per year or \$65 for 3 years. There's only 1 full time employee and 2 part timers in the office. All others are volunteers. There is also our legal counsel (Lee Colling) and a lobbyist (Nancy Stewart). Both long time, hard working advocates for us. There is also the web site and a magazine. Please join! You can join on line – FMO.ORG – or stop by and fill out an application that I will send in for you. Don't hesitate to ask any questions.

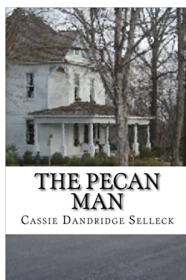
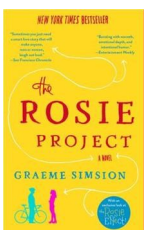
BookClub

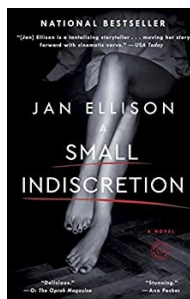
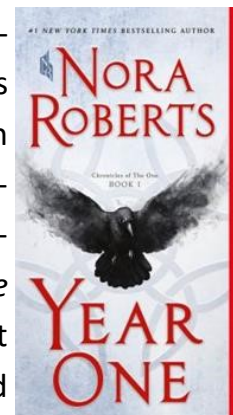
It's been all about Covid19—except in our imaginations! While the pandemic put libraries out of commission for a few weeks, it didn't take long for the “**Better Than Therapy Book Club**” readers to return to their list of titles. We had chosen some personal favorites for the summer, so the April closing did not affect us too greatly.

Suggestions included *The Rosie Project* (Carol Roberts,) **book one of a comedy trilogy** by Graeme Simsion. The novels trace the wacky love story between Rosie Jarman, a barmaid who is searching for her biological father,

and Don Tillman an obsessive-compulsive yet brilliant scientist who is searching for a wife. As they collaborate on both “The Father Project” and “The Wife Project,” they fall in love. *The Pecan Man*, suggested by Kim DesRochers, has been described as *To Kill a Mockingbird* meets *The Help*. Set in 1976 Florida, a homeless black man is accused of a murder he didn't commit while the real perpetrator leaves town only to be killed in a car accident. Those who know the truth keep the secret until only one living person remains to unravel the mystery. In *Year One* (of the *Chronicles of One* trilogy,) romance writer Nora Roberts turns her talents to **apocalyptic dystopian fantasy**. Suggested by Roberts fan Sue Fur-



ry, *Year One* sets the groundwork for “the Doom” which kills most of the world's population and mutates others into fantastical and magical beings. Reminiscent of Steven King's *The Stand*, groups of survivors meet up and travel together. Toward the end of the novel, one pivotal character becomes the focus, and her story continues in the sequels *Of Blood and Bone* and *The Rise of Magicks*. By the time we could meet again in August, we were back on track with our list.

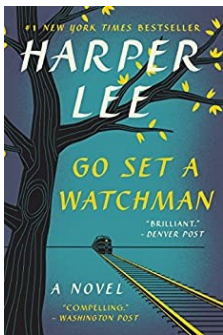


In **August**, we read *A Small Indiscretion* by Jan Ellison. This debut novel is an **emotional and suspenseful mystery** with revelations that continue and relationships that evolve until the final pages. Character

Annie Black confesses to her husband the reckless details about her youthful adventures as an office assistant in London and about her recent trip back there. Three days later, an overflowing claw-foot bathtub falls through the ceiling over her store, The Salvaged Light, and wrecks the place. Later that night, her son and her salesclerk, a young woman named Emme Greatrex, are in a terrible car accident; her son is taken by helicopter to the hospital where he is in a coma, and Emme disappears. Then, her husband asks for a separation and moves out. Narration switches from Annie's life in London at age 20, to parts of the recent past, and



to present-time chapters that cover the year following the accident. Events and recollections are shuffled together in a way that reveals only one plot element at a time. With her son in a coma, her husband in his own apartment, and her daughters in neglect, Annie's libertine past has come back to haunt her. **September's read**



was ***Go Set a Watchman***, by Harper Lee. Chosen by Deb Brown, Lee's novel is a posthumous publication said to be a **first draft of the famous *To Kill a Mockingbird***. This "second" novel shows

cases the same characters we all grew to love in *Mockingbird*, but set twenty years later. Scout is now a grown-up Jean Louise; Jem, sadly, is dead, and Atticus is revealed as a racist. Written in the third person, from Jean Louise's point of view, it recounts a visit from her home in New York City to Maycomb, Alabama. Her return forces her to come to terms with views on race and segregation, with racial and class prejudice, with a small town's hypocrisy and small-mindedness. Her struggle forces her to have understanding and forgiveness for the bigotry she encounters in her own loved ones. In **October**, we read Floridian Patrick Smith's historical novel ***A Land Remembered***.

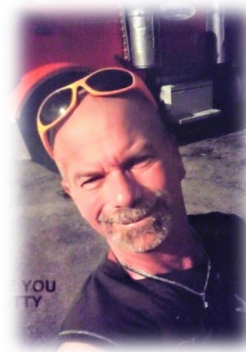
