I take off for a few weeks and everything hits the proverbial fan! Well not completely unexpected as most of this I have been telling everyone about for almost a year but everything coming together at the same time just adds to the fun.

This month and until January we've got lots of stuff going on. So everyone get back here and join in. First on the list is Rent Negotiations. For the first time in probably forever we are contesting the Rent increase this year. To say that we are forging into unexplored ground is an understatement. We have appointed a Negotiating Committee and personally I am thrilled at how they have stepped up and dug into the job. They have put in an amazing amount of effort in a very short time. Whatever the results I am very grateful for their effort and passion. Our Committee consists of Kim Desrochers, Carol Roberts, Deb Brown, Jerry Kolwalski and Joe Feltner. Will Johnson 2nd VP was assigned as HOA Board representative. These members are working to try and get us a fair deal from ELS. It is very challenging endeavor.

A new surprise was the Tie Down Program initiation. This Tie-Down Program was started many years ago as an effort by the FMO to get State Legislation to help protect Mobile Homes from serious wind damage. The program was supposed to have ended last year but due to real effort by the FMO to fight resistance by some Legislators they got the Program funded for at least another year. This year our Park made it to the list. I personally believe Ron Grove was very instrumental in getting us on the list. So he deserves a big thanks from everyone. We have put out lots of information on the Program so I won't rehash all that. Here is the important part right now. The Contractor estimates their arrival near the end of November. Applications will be accepted up to the start of construction so you have time to get your forms in. This is a



government paid project so there are exceptions. The biggest is the contractor will not go into sheds or screened rooms. So for many of us a large portion of at least one side can not be included. The contractor will be doing a survey before commencement of each home and will provide a form showing what they can and can't do. Another potential issue is items in your driveway and around your home. Items will need to be moved away from your skirting, cars, tables, cabinets, potted plants etc. Planted plants if they are in the way are up to the homeowner to move. They will work around what they can. The HOA met with Management and secured permission to use the Storage yard for temporary parking, if needed. We will need volunteers to help residents move things away from their homes and help where possible. They anticipate 10-12 homes done in a day. We currently have approximately 100 residents signed up.

Nominations Committee: Board elections are coming up in January. A committee has been appointed to secure nominations for Board Officers. Again, HUGE thanks to the residents that stepped up and agreed to help. Carol Roberts, Deb Brown, Mary Jane Beckhans. (Did you notice some repeats from the Negotiating Committee?) Yes, Huge Huge Thanks. They have compiled a list of possible Nominees that they will release at a later date. If you're interested in helping your fellow residents please contact any of the Committee members and have them put your name on the list.

By-Laws: the proposed By-Laws have been agreed upon by the Board. They will now be presented to the General Membership for acceptance. The Board has printed a copy of the Proposed By-Laws and will be giving or mailing a copy to all residents. We believe that this vote is important enough to garner this expense and effort. The date for the vote on the By-Laws is set for November 16, 2021 at 6:00 PM. at the Clubhouse. If you can not attend a Proxy form will be available soon.

We will be holding two informal meetings in the next couple of weeks to answer any questions residents may have about the Proposed By-Laws.

Annual General Meeting: Because of this Covid thing that most of us have heard about the Board was unable to arrange the mandatory Annual Meeting last January. We were forced to postpone 'til January 11, 2022, at 7:00 PM at the Clubhouse. At this meeting we will be electing New Board Officers as all but Will Johnson has worn out their welcome. Actually, term limited but probably the same thing. Proxy votes ARE NOT allowed for elections. So be there.

I really didn't mean to put this on the bottom of this Newsletter but here it is. As most of you may know. Our Park Manager Linda Nier has taken time off. Her position is being left open for an indeterminate time. ELS will be assigning Park Managers from neighboring parks to act in her stead. In the office we have Assistant Hope Clark; she is here daily. I personally wish Linda a quick recovery, good health and Happy Holidays.

This hasn't been one of my longer chats but it has had quite a bit of news in it. Since my wife and I got back from our little trip I have been scrambling to get caught up with all the "stuff" that needs doin'. Still on my list is to get wife's broom ready for Saturday. She wants it detailed and some tricked out under-glow lights put on it. Still waiting on a FedEx from Salem MA.

Things are different at the FMO. I surely never expected to be president but I am. And I am most pleased that Karen Kellen has agreed to be our park representative. She will do a great job! She is getting involved deeply with the tie-down program coming our way. By the time the Seagull comes out we will have had our introductory meeting with Storm Ready Services who will be doing our work. For a little background FMO got a bill passed 21 years ago for the state to collect a \$1 from each insurance company writing a policy on a Florida mobile home under the Department of Emergency Management. This was to provide, at no charge to the owner, new tie-downs for homes built before 1999. Parks had to sign up to get on the list for service. The bill was originally for 10 years and got extended for another 10 when that expired. Then it was to expire again this year so our FMO major effort was to get it renewed for another 10 years. The bill had to go through 6 committees and it sailed through 5 but then hit a road block with a chairman from the panhandle who thought after hurricane Michael this was a waste of money. Luckily we stirred up enough opposition that he gave in but for only one year. And now to bring this home, we have come up on the list to be serviced. Currently the "waiting" list is approximately 7 years long. So again this year, FMO will be making a major effort to get it extended. And we will try for the 10 years. Our legislative counsel, Nancy Stewart, who has represented the FMO for over 20 years, is one of our only 5 employees who earn any pay. We have 2 full timers and 1 part timer in the Largo office, Nancy and our legal counsel, Robert Burandt. All the rest of FMO leadership are volunteers. So you can guess at this point that I really hope all our residents will

join the FMO. It's only \$25 for year or \$65 for 3. These memberships are what we survive on. We are lucky in getting in on the tie-downs but there are lots out there yet to be done. Our other legislative effort this year is the greatly increase the penalties that the Department of Business and Professional Relations (DBPR) can assess on park owners who don't comply with Chapter 723. These fines haven't changed in 20 years so you can imagine they are pretty small for the big corporations now owning and buying parks in Florida. There have been some real horror stories lately. I do hope you will consider being an FMO member. You can see Karen or me for an application or go to our web site FMO.ORG to join. We need you!

Last year at this time, I glibly philosophized that **“the more things change, the more they stay the same.”** Little did we know how long changes would stay the same as *“The Pandemic,”* aka COVID-19, continued to cause illness and everyday disruption.

Our Clubhouse remained closed to activities for eleven months, until mid-February 2021, when it was reopened weekdays only for limited hours of 8 AM to 4 PM and to activities of 10-12 persons, additionally requiring sanitizer, masks, and social distancing. This limited operation continued until April 1, 2021, when occupancy was raised to 20 people in the main clubhouse, and operation returned to regular hours, including weekends. With the reopening to higher occupancy, masks and social distancing were still in force, and the kitchen remained closed.

Happily, we could use our outside amenities, and after a two-three week closure, the pool was available from 8 AM to 4 PM. Unhappily, only eight persons could use it and only for two hours at a time. It wasn't until April 1, 2021, that normal pool use resumed.

Finally, in June, we could use the Clubhouse again for gatherings, and our Birthday Babe Sue McFadden held parties for June, July, September, and October! August required another closure in the Clubhouse, this time for repairs to the library and bathrooms, so no party was planned.

And now, in late fall of 2021, we are ready to carry on. Halloween Weekend featured house and golf cart decorating contests with prizes for the winners. A Roaring 20's costume party on Halloween night marked the happy return of the 2020s. A Veterans' Day celebration and remembrance is on the calendar. Thanksgiving plans are in the works, and Christmas holiday events will follow. Soon seasonal residents will be back in their homes and all will seem right with the world.

Finally, current developments in the ongoing storage situation need attention. The “Shed Committee” of 2020 is reinvigorated by ELS's offer of rent-free space in the

Membership in the Social Club is \$12 per person, per year, which funds activities, entertainment, and services to everyone in the community—providing coffee and kitchen supplies year round, sponsoring free holiday dinners at Thanksgiving, Christmas, and Easter, and organizing a Birthday Bash each month for those celebrating birthdays. Traditional Social Club activities and parties also include New Year's Eve, Valentine's Day, April Fool's Day, Memorial Day, Fourth of July, Labor Day, Halloween, and Veterans' Day.

Social Club meets on the first Tuesday of each month at 7:00 PM in the Clubhouse. Meetings typically last about an hour and are followed by cake and coffee.
