Unless the trash company gives you a different day for large pick up.
- ♣ I know we have speeders in the community. But I have seen more speeders than usual. PLEASE slow your roll down. I don't want to see anyone hurt and I know you do not either so PLEASE SLOW DOWN!
- ♣ If you feel you need help with any issue, if you need help with your 360 inspection, please contact the office and let us share your needs with the proper people. It helps us to help you.
- ♣ Boaters and RV persons who store in the compound, when you return next year please remember to bring copies of your



titles and insurance of the items you store in the compound or boat slip. When canceling a storage or boat slip you **MUST** give in writing 30 Day notice to remove your item and return your key to the office.

- ♣ When you want to make changes to the exterior to the existing home all changes must be submitted to the office and signed off on. Even if you are painting your home the same color it must be approved through the office. No changes to the exterior to your home may be made without prior approval through the office.
- ♣ As a reminder the pool hours are from 7am to 10pm
- ♣ Nina and I are soon going to be making out follow up inspections to the 360 inspections and as a reminder, please clear all clutter up around your home.
- ♣ Please remember to not park on the grass. I know I keep threatening that I am going to post the signs and notify you of the changes, but I have been dragging my feet because I just don't want to do that to you. But for those who insist on parking vehicles and golf carts on the lawn you are going to force me to start towing. When it is so simple...just don't park on the grass.
- ♣ As a reminder when renting a slip at the boat marina, please remember you are just renting that slip. If you need to add or feel you need additional support to get in and out of your boat that please speak to the office prior to making any attachments to the slip. I understand the need for safety. We want you to be safe, but you need to speak to the office prior to placing handles, braces etc. to the existing structure.

I know most of you know that Danny is leaving or has left by the time you read this. His last day is the 28<sup>th</sup> of February. It has been a pleasure to have Danny with us, he has made a difference in all our lives. He is always willing to go the extra mile and his smile and warm personality will be missed forever. Your HOA has not been real busy since last month but there are a few things I want to pass on.

**Meetings:** The Board of Directors will be holding monthly meetings to make sure that we are addressing issues in the community and to keep up on the projects we have decided need addressing. We have also decided to have a Members meeting every two months to make sure we are addressing issues and keeping the membership up to date. A quorum should not be necessary. During the summer we will probably back off with only one meeting unless the Board members determine one is necessary. the legal requirements and changes in laws as well as Best Practices.

**Communications:** This year's Board is working on improving communications with the Membership. With suggestions from the Florida Mobile Home Owners Association we are taking steps to improve. They strongly recommended that as a Board we work harder at maintaining an up to date membership registry. Lakeside Management has agreed to assist in helping keep our records current. Presently we are limited to postings in the Kiosks, Clubhouse, the Seagull, US Mail and word of mouth to get information out. We want to pursue more up to date and faster methods so we will be working on collecting email and or text numbers and the required waivers to use these methods to communicate. We anticipate providing forms for the information that will be needed. Please be patient and let us know your concerns. In the same area we are setting up an HOA Email address for the officers to keep communications business compliant and facilitate two-way communication.

**Water and Sewer:** A frequent topic of conversation is our water and sewer services. We have decided to address this question. Our first step is researching how we got into this situation and why are we different from the neighboring housing. Be patient please while we get GOOD information. Then we can decide how we may want to proceed.

That is about all for this month. Please remember our friends and family that are dealing with "Real" winter with ice, snow and freezing temperatures. I enjoy sending them pictures of palm trees, sandals, swimming pools and complaining about our temperatures. Sure seem to have a real impact on their mood. 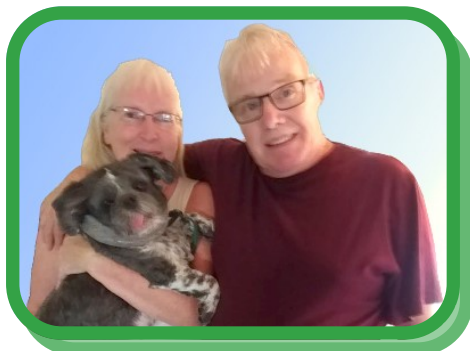

## The Ragman's Son

This week I heard about the death of one my heroes. Kirk Douglas passed at 103 years old. I imagined that he had a very happy and fulfilling life. He acted in many great movies such as 'Lust for Life' and who could forget his role in Spartacus or the line "I am Spartacus!"

He had a son Michael from his first wife. Michael followed in his fathers footsteps including acting, writing, directing and producing. His father must have been exceedingly proud.

I may have mentioned before that I worked at a rehab for dual diagnose patients. That meant along with a psychological problem, they had addiction issues. This was a very exclusive place in the middle of nowhere in New Jersey. It was too far for any client to walk off and hidden enough that no paparazzi could get close.

They were very wealthy and often famous. A son of a presidential candidate, a former Miss America, and if you have ever bought gas at a gas station, you would recognize one clients last name.

Although it was open to both men and women, they were kept strictly apart. Women on one side of the room and men on the other. They were forbidden to speak to each other. There were many rules including men having to dress for dinner (suit and tie) and women could wear skirts or dresses not above the knee. Only Sunday could women wear dress pants.

My job was to be in charge of approximately 30

to 50 women. I ran groups, inspected rooms for neatness and items that were forbidden. Listened to the women as they explained how they got to be in such a place. The clients stayed at least a year and though they probably hated me in the beginning (Behind my back they called me the Enforcer) as time went by, they found I was fair. Often they would write to me when they left.

One day a new client came to stay. He looked familiar to



me. He was concerned that being in rehab might ruin his 'career' I was very interested in stand up comedy and even considered it as a career. Yet Eric did not look like any of the comics I knew. Then I remembered I had seen him on t.v. He had been aboard an airplane and was so drugged out his mind that the plane had to make an unscheduled landing. He was consequently arrested.

That night, we were short staffed and the boss asked me if I would answer the 800 hotline. I hesitated and then he said "It pays double time" As you can guess, I said yes.

Many calls came in from friends, family and often people under the influence reaching out for help. I should mention, clients could not speak or see their family for six months. Often it took one conversation to undo all the growth the patient had shown. A slurry voice said

"Hello". From my past experience, I assumed it was an alcoholic searching for help. I identified myself and he said "Hello Diana. My name is Kirk Douglas and my son Eric is a patient there I am calling to make sure he arrived." I immediately thought of his biography 'The Ragman's Son' where he told of growing up the poorest of the poor and still he made himself into a star. We spoke for a while and like many parents, he blamed himself for the mistakes his son made. "Maybe I should have spent more time with him." " Maybe I should have been more accepting of the fact that he was gay." He began to cry. I was shocked that my hero was crying. I wanted to reach out and hug him and tell him that it would all be alright. I knew the odds were against that happening but I said we were doing all that was possible to help him. Through his sniffles he said "Thank you Diana. I pray that you are right"

However the world may have viewed Kirk, a star, a success, a very wealthy man I knew he was a father with a heart breaking into small pieces and I was a voice on the phone listening to his pain and trying to provide some small comfort. Despite the staff doing all they could, Eric left treatment early.

I so wish I could give this story a happy ending. Eric died from his addiction July 6, 2004. I am only able to tell this story now because the non disclosure agreement I signed became null upon the death of those involved. RIP Eric and Kirk

## Still Reading After All These Years

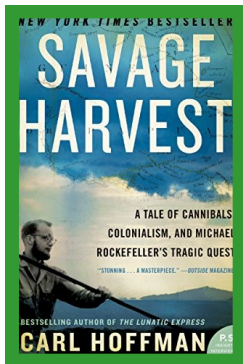
And this month . . . something savage: a look at one of the most powerful taboos of western culture. *Savage Harvest: A Tale of Cannibals, Colonialism, and Michael Rockefeller's Tragic Quest for Primitive Art* by Carl Hoffman.



In 1960, Michael Clark Rockefeller, son of Nelson Rockefeller and Mary Todhunter Clark, began an adventurous journey to New Guinea in search of indigenous primitive art for a collection to be established at his father's new Museum of Primitive Art. Rockefeller had made some contact with Dani and Asmat tribes on an expedition for the Peabody Museum of Ethnography and Archaeology, and after their documentary was completed, he decided to return to Southeast New Guinea to study and collect Asmat art and artifacts. Returning by boat to the Asmat village of Otsjanep late in 1961, he and Dutch anthropologist Rene Wassing were capsized by a sudden storm and driven further and further from the shore by the currents. About twelve miles from shore, Rockefeller told Wassing that he could swim for it and left the

capsized boat. Wassing was rescued the next day, but few traces of Michael Rockefeller's swim were found. His body was never recovered. Many theories have attempted to explain his disappearance, but the official cause of death was listed as drowning.

The waters off the coast of New Guinea are shark infested, and the brackish shorelines are home to large crocodiles. Inland, the Asmat tribe themselves were fierce cannibals. During the extensive and concentrated two-week search for Rockefeller, theories of shark or crocodile attacks and rumors of ritual killing by the Asmat surfaced. But the Dutch government gave no credence to the rumors or to the rumored possibility that Rockefeller might be alive and living as a "native." His parents, who traveled to New Guinea to support the search, left the island.

Nevertheless, the mystery of Rockefeller's death continued to spark investigation and speculation. Articles, books, and movies explored both New Guinea and the disappearance. In 2014, more than 50 years later, Carl Hoffman decided to investigate the many claims surrounding the fate of Michael Rockefeller. Hoffman's book, which revisits both Michael's life and goals and the arguments and claims of earlier works, attempts to prove—one way or the other—whether Michael Rockefeller was the victim of ritual revenge. A gifted journalist, Hoffman creates a vivid portrait of the world of the Asmat in New Guinea. His writing blends imaginative speculation with solid research and objective reporting to give the reader a thrilling story, but one with no real resolution. This book is a fascinating look at privilege, prejudice, and primitivism.

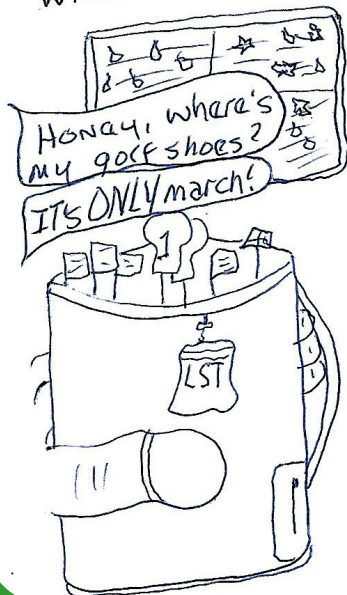
